elcome to the inaugural sustainability report of Denim Expert Limited. There is a reason why this is our first report on this vital industry issue. At Denim Expert Limited, we don't talk much about sustainability. Instead we DO it. Sustainability is in our everyday actions, whether that be our production processes which are constantly refined and fine-tuned to minimise their environmental impact or the respectful, inclusive way in which we treat our valued members of staff.

My message here is clear: Sustainability cannot and must not be a 'bolt-on' for any business. It must be core to the business DNA, front, back and centre of everything the business does. Sustainability must be a part of everyday business life and, as such, doing business sustainably – doing business the right way not to make a quick-profit – needs to be embraced by all members of the team.

As an international denim manufacturer, I aim to lead from the front on the issue of sustainability and encourage my team to follow me on this journey - not through my words but my actions.

As the head of an international business in this industry, which supplies products to many of the world's leading apparel brands, I am acutely aware of the burden of responsibility that falls upon my shoulders. The actions of my own business and many others like it could have a profound impact on the lives of future generations on earth. If we make the wrong choices now, and the consequences for the environment and mankind could be catastrophic.

This is not hyperbole: The stakes, quite literally, higher and not be higher.

Around the world, young people march and demonstrate on climate and environmental issues. They want change, they want businesses to make better choices for the environment, they want organisations like my own to make smarter decisions for their futures.

We have to do the right thing by them. So sustainability, for us, is not just the obvious choice. It is the only choice, for we know which side of history we want to be on.

SETTING CLEAR TARGETS

In 2019, Denim Expert Limited took the unprecedented step for a denim manufacturer to set clearly defined sustainable goals and targets across a number of areas.

The focus of these goals is on seven key areas of operations, allocating targets to be achieved based on our 2018 baseline data.

The 7 key areas identified are:



ENERGY By 2022, Denim Expert Limited aim to be sourcing renewable energy wherever feasible in its operations and has set a target of 1.35 kWh/ Kg in energy used for each product, a 23.5% reduction compared to 2018 baseline data.



WATER By 2022, Denim Expert Limited will reduce the amount of water used per unit of garments in production to 55-65 litres/unit, a 23% reduction in water usage compared to 2018 baseline data.



CHEMICAL By 2020, Denim Expert Limited will be complying with the Zero Discharge of Hazardous Chemicals (ZDHC) effluent standards. The total chemical management improvement will be 100% against 2018 baseline data.



ENVIRONMENT By 2025, Denim Expert Limited is going to be implemented ZLD (Zero liquid Discharge) & already management has taken proposal from many world wide supplier.



EFFICIENCY By 2022, Denim Expert Limited is going to be implemented its production efficiency improved 70% according to its 2018 baseline data.

INITIATIVES

The ZDHC Roadmap to Zero Programme is a coalition of fashion brands, value chain affiliates and associates. The programme aims to empower the global textile, leather, apparel and footwear value chain to substitute hazardous chemicals for safer ones in the production process.

By collaborating with ZDHC, organisations can mitigate risk, respond to changing customer demands, cut costs and preserve valuable resources.

By adhering to the programme and contributing to the work of the foundation, Denim Expert Limited commits to:

- Establishing traffic signal symbols in the chemical store-room to aid in the safe storage of chemical product.
- Using PPE when handling chemicals.
- Introducing a chemical compatibility chart to ensure safe storage of chemicals and highlight their risk factor.
- Installing appropriate ventilation and temperature control in the chemical storage area.
- Establishing an emergency response plan, with any potential chemical spillage being monitored by a specially trained technical representative.
- Labelling all chemicals following ZDHC guidance.

Denim Expert Limited Has Installed A Hybrid, Custom Designed, Mechanical Chemical Effluent Treatment Plant (ETP) At Its Manufacturing Facility, Treating All Effluent From Our Laundry.

THE GOAL AT DENIM EXPERT LIMITED IS TO RECYCLE 100% OF EFFLUENT WATER MEANING THE ACHIEVEMENT OF ZERO LIQUID DISCHARGE. THIS WILL HAPPEN IN THE NEXT THREE YEARS.

To achieve its far-reaching discharge goal, Denim Expert Limited will work from the principle of the 3R project: Reduce, Re use & Recycle.

- PLAN FOR ACHIEVING ZLD AT 1ST PHASE: Denim Expert Limited is recycling and reuse 15% of process water for toilet flash, gardening and floor cleaning.
- PLAN FOR ACHIEVING ZLD AT 2ND PHASE: Denim Expert limited is recycling and reuse 20% of process water for Fire hydrent, ETP chemical dosing, car and road washing.
- PLAN FOR ACHIEVING ZLD AT 3RD PHASE: The factory will reuse the remaining 65% of the waste water directly in the process through implementation of modern membrane technology including ultra-filtration and reverse osmosis.

Circular fashion can be defined as clothes, shoes or accessories that are designed, sourced, produced, and provided with the intention to be used and circulated responsibly and effectively in society for as long as possible in their most valuable form, and hereafter return safely to the biosphere when no longer of harm to human or environment.

Denim Expert Limited new circular line is based on three types of circularity. This begins with circularity in the design process, in terms of the materials use and finally with regards to product use.

The base concept is to make a fusion in between ancient dress up and modern design so that a user will feel both image in a single dress.

The Circularity products will be developed by minority employees at Denim Expert Limited including transgender employees, people with disabilities and people who have been the victims of human trafficking.



The need for speed and the growth of fast fashion means the demands placed on manufacturers like our own are ever greater. Brands themselves who place these demands are also under huge pressure themselves due to massive competitive pressures in the global industry.

COLLABORATION

In such a scenario it can easily become 'dog eat dog' but at Denim Expert Limited we preach collaboration and mutual benefit. We seek to establish long-lasting, partnership-based relationships with brands where there is openness, honesty and transparency at every step of the process.

There was a time when brands could ignore sustainability issues but those days are gone. We have seen a wide range of campaigns in recent years from organisations such as Greenpeace, Clean Clothes and Labour Behind the Label. These campaigns have often caused huge negative publicity for brands and consequently forced them to act on issues such as the use of child labour, the use of toxic chemicals in their supply chains and the incineration of clothing.

Bangladesh has often been at the centre of discussions around these issues. There are a couple of reasons for this. One of them is the fact that as a country, Bangladesh is the world's second largest exporter of clothing. The other reason, of course, is Rana Plaza, a terrible tragedy which fired Bangladesh onto the front pages of newspapers around the word.

With all the above in mind, it can be easy to despair when considering the global apparel industry and its supply chains. Dirty, polluting production methods, labour exploitation, unscrupulous buying practices - these are phrases we hear all the time.

ANOTHER WAY

But it is our firmly held belief at Denim Expert Limited that it needn't be like this. There is another way.

Our vision at Denim Expert Limited is of an industry which collaborates for mutual benefit. An industry underpinned by fairness – where consumers pay a fair price for clothing, where brands pay a fair price to suppliers and where suppliers pay a fair wage to their staff.


Making use of fabric waste in garment factories
